



## **COVID-19 Safety Protocols**

October 27, 2021

As of October 22, 2021, you must be fully vaccinated or have an approved medical exemption in order to access gatherings of any size held for socializing, celebration, ceremony or entertainment that are hosted at a recognized business or organization, a rental room, community centre, or other venues used to host gatherings.

## What you need to show for proof of vaccination:

- 1. VALID VACCINE PASSPORT containing a QR code
  - a. EITHER via NLVaxPass app
  - b. OR printed QR code

- 2. **IDENTIFICATION** all individuals ages 12 years and older are required to show identification with their proof of vaccination. This must include:
  - a. *EITHER* one photo ID with name and date of birth (e.g., driver's license, government identification Card, passport, student identification card).
  - b. OR two IDs with name and date of birth on at least one (e.g., birth certificate, MCP card).

## **Out-of-Province Proof of Vaccination**

You can use your vaccination record from your home province, territory or country to show proof of vaccination. Your proof of vaccination must clearly indicate that you are fully vaccinated (14 days since your last dose). You must also show identification.

Our collective safety is of paramount importance and all required public health measures will be observed. This includes, but is not limited to:

- Contact tracing contact details will be collected for all individuals in attendance, including performers, staff, volunteers, and audience members.
- Reduced venue capacity seating limits will follow Government of NL guidelines. We will ask patrons to sit in "bubbles", wherever possible, to ensure proper physical distancing can be maintained.
- Pre-screening any person experiencing <u>symptoms of COVID-19</u> is asked to stay home and complete the <u>COVID-19</u> self-assessment tool or contact 811. Individuals from a COVID-19 hotspot will not be permitted to attend.
- Ventilation this may mean open doors/windows, so dress accordingly!
- Physical distancing a minimum of 6' between all individuals/bubbles will be enforced wherever possible. The choir will also be positioned such that they are appropriately distanced from the audience (minimum 12').
- Increased hygiene/sanitation practices will be in place.
- Mask-wearing will be enforced all guests must wear a non-medical mask upon entering the venue until they exit at
  the end of the show. The choir will wear ASTM Level 3 surgical masks during their performance... don't worry, this
  doesn't impede the singing!
